In the reference 1<sup>st</sup> cited, Government have permitted the Commissioner & Director of School Education, AP, Hyderabad to complete the recruitment process and appoint eligible candidates for various categories of posts in clear vacancies only, subject to number of vacancies notified under each category by following the provisions of the A.P. Direct Recruitment for the posts of Teachers (Scheme of Selection) Rules-2012.

2. The Commissioner & Director of School Education, AP, Hyderabad in his letter 2<sup>nd</sup> cited has requested the Government to issue necessary clarification on implementation of Rule of reservation including Local and Non-Local candidates for making selection for the notified posts in DSC-2012.

3. After examination of the matter and in continuation of the G.O. 1<sup>st</sup> cited, the Commissioner & Director of School Education, AP, Hyderabad is hereby informed that in making the Direct Recruitment the percentage prescribed in the Presidential Order for the Local candidates and for un-reserved (both Local and Non-Local) vacancies, respective points shall be maintained. The un-reserved vacancies to which both Local and Non-local candidates can compete shall be filled up first before making selections for the local candidates as per the percentage. A clear cut off line should be drawn between un-reserved (both Local and Non-local) and the vacancies meant for Local candidates. The recruitment should be strictly in accordance with percentage duly following the Rule of reservation.

4. The Commissioner & Director of School Education, AP, Hyderabad is also requested to follow the G.O.Ms.No.8 GA (SPF) Department, dated:08.01.2002 and also following the instructions issued in Circular Memo No.46614/Ser-A/2005-1, GA (Ser-A) Department, dated:27.05.2005 and duly following the roster points indicated in Rule 22 (2) (e) of the A.P. State and Sub-ordinate Service Rules.

5. The Commissioner & Director of School Education, AP, Hyderabad is requested take necessary further action accordingly.
